All organizations under the Executive Committee and all bureaus under the Office, relevant entities stationed in the zone:

In accordance with the Master Plan for the Construction of Guangdong Macao In-Depth Cooperation Zone in Hengqin, the Master Plan of the Development of the Guangdong-Macao In-Depth Cooperation Zone in Hengqin, and relevant national financial and tax policies and customs supervision measures, the Guidelines on

Declaration of White List for Transit via the "Second-line" (hereinafter referred to as the record list) in the Guangdong-Macao In-Depth Cooperation Zone in Hengqin (for Trial Implementation) is hereby issued to you. With the approval of the Executive Committee and the Office, the Guidelines is aimed at achieving effective supervision and convenient passage of the "second-line" in the Guangdong-Macao In-Depth Cooperation Zone in Hengqin (hereinafter referred to as the "Cooperation Zone"). Please organize and implement it carefully. The relevant matters are notified as follows:

I. Attaching Great Importance and Ensuring Effective Management

All relevant entities shall attach great importance to the declaration of the record list. They shall strengthen unified deployment and coordination, supervise its implementation, and designate special personnel to be responsible for the management of the record list, creating a favorable environment for the special customs operations in the Cooperation Zone. After that, they shall also work with the customs department to achieve effective supervision and convenient passage. Please verify whether the relevant personnel are affiliated with their entities in a prompt manner. When changes occur to the record list, prompt update and verification of the information of personnel and vehicles on the list should be conducted to ensure the accuracy, validity, and completeness of the information.

II. Thorough Publicity and Voluntary Declaration

All relevant entities shall properly publicize, guide, declare and upload the record list. The Administrative Affairs Bureau and the Economic Development Bureau of the Cooperation Zone, the Work Committee of the Guangdong-Macao In-Depth Cooperation Zone in Hengqin of the CPC Guangdong Provincial Committee, and the Party Building Department of the Office of Hengqin shall carry out extensive publicity work. The Commercial Services Bureau of the Cooperation Zone, the Work Committee of the Guangdong-Macao In-Depth Cooperation Zone in Hengqin of the CPC Guangdong Provincial Committee, and the Social Affairs Bureau of the Office of Hengqin shall provide good publicity and guidance for enterprises, social

organizations, and Hengqin residents. After the issuance of this notice, all relevant entities shall voluntarily and independently apply for login accounts and permissions on the Smart Port Public Service Platform of the Guangdong-Macao In-Depth Cooperation Zone in Hengqin. They shall promptly submit the record lists according to the relevant procedures and requirements.

Interim Guidelines on the Declaration of White List for Transit via the "Second-line" in the Guangdong-Macao In-Depth Cooperation Zone in Hengqin

In accordance with the Master Plan for the Construction of Guangdong Macao In-Depth Cooperation Zone in Hengqin, the Master Plan of the Development of the Guangdong-Macao In-Depth Cooperation Zone in Hengqin, and relevant national financial and tax policies and customs supervision measures, the Guidelines on Declaration of White List for Transit via Second-line (hereinafter referred to as the "record list") in the Guangdong-Macao In-Depth Cooperation Zone in Hengqin is formulated base on the actual situations. These Guidelines is aimed at facilitating the passage of vehicles driven by personnel from relevant entities and enterprises in the Guangdong-Macao In-Depth Cooperation Zone (hereinafter referred to as the "Cooperation Zone") and achieve effective supervision and convenient passage.

I. Scope of Application

- 1. The scope of the Cooperation Zone is the customs supervision area between the "first-line" and "second-line" of the Hengqin island. The "first-line" refers to the boundary between Hengqin and Macao, while the "second-line" refers to that between Hengqin and the rest of the Chinese mainland.
- 2. The record list refers to the list of entities, personnel and vehicles that are active within the Cooperation Zone and frequently pass through the zone via the "second-line", and is applicable to the traffic management of the "second-line" in the Cooperation Zone.

II. Smart Port Public Service Platform

The Smart Port Public Service Platform (hereinafter referred to as the "Public Service Platform") is built and operated by the port administration authorities of the Cooperation Zone. It is based on the "Digital Government" government cloud platforms of Guangdong Province and China (Guangdong) International Trade Single Window. This serves as the Public Service Platform for declaration of the white list for transit via the "second-line" of the Cooperation Zone.

III. Applicants

Applicants for this record list must meet one of the following requirements:

- 1. Official vehicles of the Party and government entities, public institutions, statutory bodies and entities stationed in the Cooperation Zone and their drivers; staff of the Party and government entities, public institutions, statutory bodies and entities stationed in the Cooperation Zone and their private vehicles.
- 2. Company vehicles of enterprises legally registered in the Cooperation Zone and their drivers; staff of enterprises legally registered in the Cooperation Zone and their private vehicles.
- 3. Institutional vehicles of social groups, non-enterprise private units and foundations that are legally registered in the Cooperation Zone and their drivers; staff of social groups, non-enterprise private units and foundations that are legally registered in the Cooperation Zone and their private vehicles.
- 4. Residents with registered household status in Hengqin or residents with a Hengqin residence permit in the Cooperation Zone and their private vehicles; staff of Community Residents' Committees and their private vehicles.
- 5. Institutional vehicles of relevant entities that need to frequently enter and exit the Cooperation Zone on official business and their drivers; staff of relevant entities that need to frequently enter and exit the Cooperation Zone on official business and their private vehicles.
- 6. Institutional vehicles of other relevant entities that meet the requirements and their drivers.

Each private vehicle is only allowed to record two drivers, one of whom must be the owner. Each institutional vehicle can record two or more drivers.

IV. Declaration of Record List

The record list is voluntarily declared by entities and individuals.

1. Register an account

Relevant entities visit the Public Service Platform, register an account, receive a declaration QR code after verification, and notify relevant personnel to declare. Each code is unique to each entity.

2. Voluntary Filing

Relevant personnel voluntarily scan the declaration QR code provided by their respective entities, fill in personal information (see Attachment 1), make a credit commitment (see Attachment 2), and upload their entities.

3. Verifying and uploading of the record list

The entity verifies whether the relevant personnel are affiliated with the entity, make a credit commitment (see Attachment 3), and upload it to the Public Service Platform.

The record list is subject to dynamic management, following the principle of "Who verifies, who manages". Residents with registered household status in Hengqin or residents with a Hengqin residence permit in the Cooperation Zone can declare through their Community Residents' Committees. Relevant entities (or Community Residents' Committees) shall manage the record list properly. When changes occur in the list, promptupdate and verification of the information of the personnel and vehicles on the list should be conducted to ensure the accuracy, validity, and completeness of the information.

V. Removal from the Record List.

1. When the record list is included in the seriously untrustworthy entities list of the segregated management, the Public Service Platform will remove the personnel and vehicles from the list and send the removal information to the relevant entities and individuals involved.

2. If individuals apply to be removed from the record list voluntarily, or leave their

affiliated entities, the entities shall remove them from the list.

3. When the entity is deregistered, the Public Service Platform shall remove the

relevant entity from the list.

VI. Information protection

1. The Public Service Platform shall comply withthe Guangdong Provincial Public

Data Management Measures, the Personal Information Protection Law of the People's

Republic of China and other relevant laws and regulations in its protective measures

for the information on the list.

2. Public Service Platform meets the Level 3 requirements of the national information

security protection.

Credit Commitment for Institutions

- 2. Vehicles and drivers on the list submitted all belong to the entity.
- 3. People on the list are all affiliated to the entity.
- 4. When using the credit pass service, vehicles and relevant personnel will abide by the relevant regulations of the credit pass management measures.
- 5. The information provided is true and valid, and the entity is willing to take corresponding responsibilities.
- 6. Except for the circumstances stipulated by laws and regulations, the data of the credit access list shall not be provided to external parties.
- 7. The entity has carefully read and agree to the above terms.
